Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

STATEMENT OF PROBABLE CAUSE

On 9/2/20 at approximately 2:25 p.m. Minneapolis Police Officers Watry and Mota were dispatched to the 27th block of Emerson Avenue South in the City of Minneapolis, Hennepin County, for a suspect breaking into vehicles. The suspect was described as a black male wearing a grey hooded sweatshirt and black pants. A second caller reported the same suspect breaking into another vehicle, a Ford F-150, at around the same time. It was reported that the suspect was trying door handles on vehicles in the area and that the suspect had multiple items in his sweatshirt pocket.

Officers located the suspect nearby and placed him under arrest. The suspect verbally identified himself as Abdirahman Ismail Farah (dob: 01/01/1998), Defendant herein. Officers located two cell phones, two wallets, a key, and cash on Defendant's person. One of the cell phones and wallets belonged to GKJ, the owner of the Ford F-150. The cell phone was valued at \$600.00. The other cell phone and wallet belonged to RJM. These items were within the vehicles that Defendant entered. Defendant did not have permission to enter into either vehicle, nor did Defendant have permission to take these items from the vehicles.

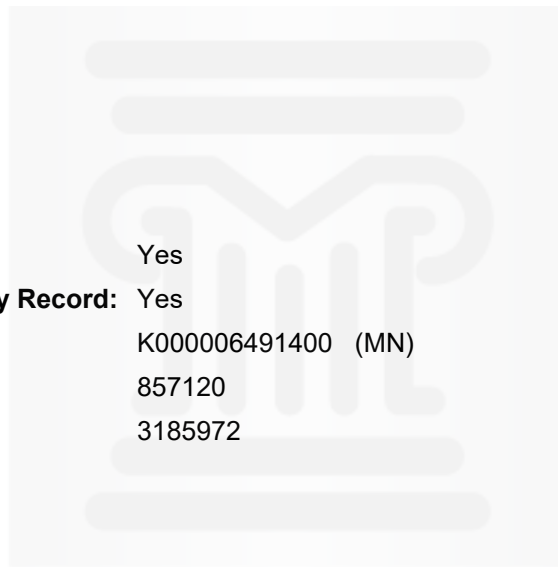
