STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On September 12, 2020, Minneapolis Police were dispatched to a park in Downtown Minneapolis, County of Hennepin, State of Minnesota, on the report of a domestic assault. When they arrived, police spoke with a known adult female (victim). Victim indicated that her boyfriend, LAWRENCE JOSEPH DURHEIM (DOB: 8/21/1971), defendant herein, had just assaulted her and ran off. Victim indicated that defendant was mad at her for cheating on him. Defendant tackled victim and slammed her head on the ground. Defendant then put his forearm on her neck and pressed down. Victim was unable to breathe. Defendant and victim struggled, and defendant ultimately got off and ran away. Officers noticed injuries to victim's neck and head area consistent with victim's account of the assault. Victim was taken to the hospital where more injuries were located on her scalp and neck area.

Defendant's whereabouts are unknown. Based on the violent nature of this assault, a warrant is requested for defendant's arrest.
