COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Assault-2nd Degree-Dangerous Weapon**

Minnesota Statute: 609.222.1, with reference to: 609.222.1, 609.11.4, 609.101.2, 609.11.9

Maximum Sentence: 7 YEARS AND/OR \$4,200-\$14,000

Offense Level: Felony

Offense Date (on or about): 10/15/2020

Control #(ICR#): 20009832

Charge Description: That on or about October 15, 2020, in the city of Robbinsdale, in Hennepin County, Minnesota, JALEISHA LANAY TAYLOR, assaulted R.A.L.T., while using a dangerous weapon.

Minimum Sentence: 1 YEAR AND 1 DAY

COUNT II**Charge: Assault-3rd Degree-Substantial Bodily Harm**

COUNT III**Charge: Assault-5th Deg-2/More Prev Convict in 3 years**

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 10/15/2020

Charge Description: That on or about October 15, 2020, in the city of Robbinsdale, in Hennepin County, Minnesota, JALEISHA LANAY TAYLOR did intentionally cause fear of immediate bodily harm or death or intentionally inflicted or attempted to inflict bodily harm on R.A.L.T., and less than three years has elapsed since JALEISHA LANAY TAYLOR was convicted of or adjudicated delinquent for the first of two or more previous qualified domestic violence-related offenses.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 15, 2020, Robbinsdale Police officers responded to a stabbing located at XX48 West Broadway in the city of Robbinsdale, Hennepin County, Minnesota.

Upon arriving, officers found the victim, R.A.L.T., who was bleeding from several lacerations. At the scene, officers discovered a broken knife that blood on the blade. Officers spoke with R.A.L.T. who stated that he was inside the apartment when he heard noises coming from the living room. R.A.L.T. went to the living room and found JALEISHA LANAY TAYLOR, DOB: 03/18/1993, Defendant herein, fighting with the apartment owner. When R.A.L.T. tried to intervene, Defendant started attacking him. Defendant grabbed a knife from the kitchen and cut R.A.L.T. on his left ear, left bicep, and on the left side of his torso. Numerous sutures were required to close the lacerations.

Defendant fled the scene prior to officers arriving.

A review of Defendant's criminal history revealed two prior domestic violence-related convictions within the past three years for Assault in the Fifth Degree in Court File Nos. 27-CR-18-8346 and 27-CR-17-16954 from May 9, 2019, and June 12, 2018 respectively.

Given the nature of the offense and the risk to public and the victim's safety, the State respectfully requests a warrant issue with this complaint.

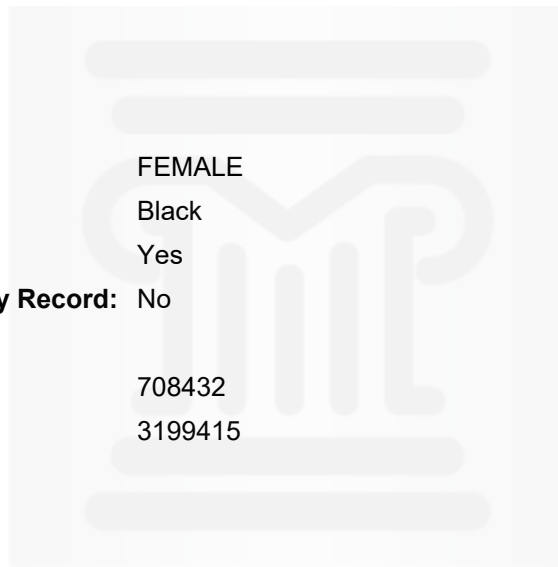
