COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Stalking - Engages in Stalking**

Minnesota Statute: 609.749.5(a), with reference to: 609.749.5(a)

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 03/25/2020

Charge Description: That on or between 3/25/2020 and 12/6/2020, in Hennepin County, Minnesota, LAMAR JOHNSON engaged in stalking conduct with respect to victim and/or members of the victim's household in a manner that would cause a reasonable person under the circumstances to feel terrorized or to fear bodily harm and that did cause this reaction on the part of the victim.

COUNT II**Charge: Damage to Property - 1st Degree - Value Reduced Over \$1000**

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about December 6, 2020 Officers were dispatched to the 5000 block of Cedar Avenue in Minneapolis, Hennepin County for a home that was damaged. This home had been targeted for repeated property damage over the past ten months. Officers spoke to the residents of the home and they indicated they were very fearful of this continued violent damage of the home. Adding one of the incidents the victim was sleeping in a bedroom as the windows were smashed out.

Officers were able to piece together surveillance from the incidents and also learned that there was DNA evidence from an October incident. This blood was rushed to the BCA for analysis.

Upon review of the surveillance a consistent vehicle was observed and investigation was undertaken to locate this vehicle.

Officers learned from the victims and prior police reports that property at this home had been damaged on March 25, May 15, May 30, June 8, September 2, October 16, November 26, December 1 and December 6, all in 2020. The damage that occurred has exceeded \$6,000 and is mostly comprised of continual shattering of windows.

DNA results yielded that it was LAMAR JOHNSON, AKA RASHEED RICHARDSON, the Defendant whose DNA was found at the home in October. It was then learned that the Defendant has a civil dispute with one of the people living at the residence. Further investigation revealed that the Defendant drives and owns the car seen in the video and search of this vehicle uncovered a distinct hammer that the Defendant used to smash out windows and also the mask the Defendant wore to attempt to conceal his identity as he carried out these continual attacks.

A search warrant was executed at the Defendant's residence in Minneapolis, Hennepin County and several firearms were found:

- two revolvers (small revolver and green revolver)
- one bolt action rifle
- one shotgun
- .45 high point
- .380 Taurus

A review of the Defendant's criminal history reveals he is prohibited from possessing a firearm due to a 4th degree drug conviction in 27-CR-06-072764 which was sentenced on 5/28/2008.

The Defendant was interviewed regarding this and admits to damaging the property and that he is furious with one of the residents at the home saying that he wished him dead and we wouldn't piss on the person's grave. The Defendant admitted all of the guns were his and that he also knew he was a convicted felon.

The Defendant is currently in custody.
