COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Threats of Violence - Reckless Disregard Risk

Minnesota Statute: 609.713.1, with reference to: 609.713.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 08/26/2021

Control #(ICR#): 21006244

Charge Description: That on or about 8/26/2021, in Hennepin County, Minnesota, Charlesetta Starlet Brown did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another, Victim.

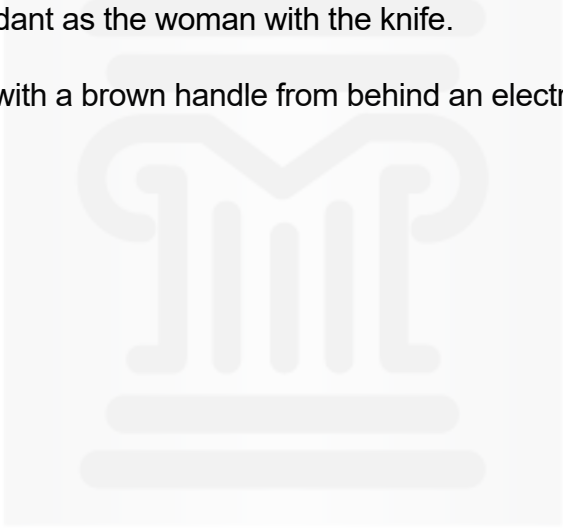
STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On August 26, 2021, officers responded to the light rail platform at Target Field in Minneapolis, Hennepin County, Minnesota on a report of a woman attempting to attack a man with a knife. Upon arrival, officers met with Victim who said that he was standing on the platform when CHARLESETTA STARLET BROWN, DOB: 10/13/1992, aka Shaniqua Melonie Dantzler, DOB 2/3/1991, Defendant herein, approached him with a kitchen knife, stuck the knife in his face, and said "what's stopping me from killing you right now?" Victim positively identified Defendant as the woman with the knife.

Officers recovered a steak knife with a brown handle from behind an electrical box.

Defendant is in custody.

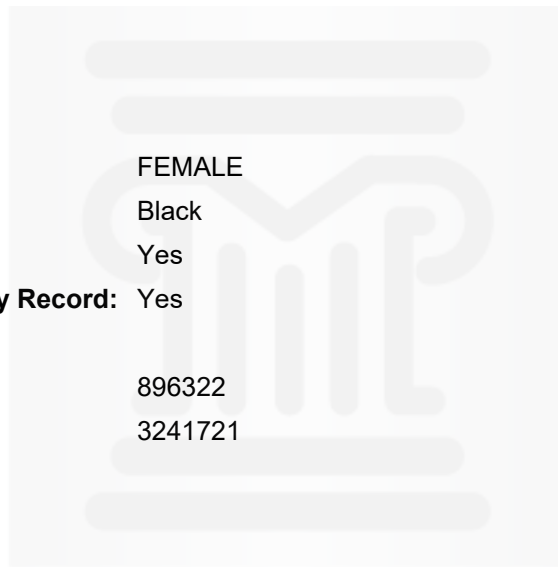
